5. The Participants are responsible for the information provided to BBF and acknowledge that the information is accurate and true. BBF reserves the right to disqualify and remove any Participant that lies during and after the registration process or at any moment and will not be liable for any costs for the Participant.
6. Participants who post about BBF on their social media and other platforms, will be taken into account for different activities during BBF selection process as well as the engagement, likes and comments achieved on those posts. All Participants agree that BBF reserves the right to use and alter all images, audio and videos posted in any format about or referencing BBF in any way or form at any time.
7. All Participants agree to be judged by the selection team and panel of judges appointed by BBF. BBF takes no responsibility for positive, neutral or negative judgments on the Participants from the selection team and panel of judges.
8. All Participants agree that BBF reserve the rights to use all images, audio and videos sent in any format from the Participants while registering for BBF and transform them into any or all forms of media currently in existence or yet to be created.
